- 1 year labor & materials for the entire system
- 5 years materials only for motor & controllers
- 10 years materials only for bearings & bushings
- 20 years for structural defects in materials & workmanship (excluding finish)

At its option, **Sun-A-Ray** will repair or replace at no charge any **Sun-A-Ray** mounting system or component of the mounting system that proves to be defective within such warranty period. This warranty shall not apply if the **Sun-A-Ray** product has been damaged by unreasonable use, accident, negligence, improper installation, severe weather conditions such as excessive wind, ice, storms or other acts of nature, service or modification by anyone other than **Sun-A-Ray**, more modules mounted on the **Sun-A-Ray** than it was designed for, damage due to improper packaging on return shipment, or by any other causes unrelated to materials and workmanship.

The original consumer must retain original purchase receipt for proof of purchase as a condition precedent to warranty coverage. The product must be accompanied by proof of purchase and Return Authorization (RA) number issued by **Sun-A-Ray**. **Sun-A-Ray** will pay all shipping charges to return any defective **Sun-A-Ray** product or component under this warranty policy.
